Intelligent Agents V: Agents Theories, Architectures, and Languages Oct 05 2020 The leading edge of computer science research is notoriously fickle. New trends come and go with alarming and unfailing regularity. In such a rapidly changing field, the fact that research interest in a subject lasts more than a year is worthy of note. The fact that, after five years, interest not only remains, but actually continues to grow is highly unusual. As 1998 marked the fifth birthday of the International Workshop on Agent Theories, Architectures, and Languages (ATAL), it seemed appropriate for the organizers of the original workshop to comment on this remarkable growth, and reflect on how the field has developed and matured. The first ATAL workshop was co-located with the Eleventh European Conference on Artificial Intelligence (ECAI-94), which was held in Amsterdam. The fact that we chose an AI conference to co-locate with is telling: at that time, we expected most researchers with an interest in agents to come from the AI community. The workshop, which was planned over the summer of 1993, attracted 32 submissions, and was attended by 55 people. ATAL was the largest workshop at ECAI-94, and the clear enthusiasm on behalf of the community made the decision to hold another ATAL workshop simple. The ATAL-94 proceedings were formally published in January 1995 under the title *Intelligent Agents*, and included an extensive review article, a glossary, a list of key agent systems, and — unusually for the proceedings of an academic workshop — a full subject index. The high scientific and production values embodied by the ATAL-94 proceedings appear to have been recognized by the community, and resulted in ATAL proceedings being the most successful sequence of books published in Springer-Verlag's *Lecture Notes in Artificial Intelligence* series.

Principles, Systems and Applications of IP Telecommunications. The workshop was co-organized by CSEC, a special interest group concerned with the computer security of the Information Processing Society of Japan (IPSJ) and ISEC, a technical group concerned with the information security of The Institute of Electronics, Information and Communication Engineers (IEICE). The review and discussions were supported by a very nice Web-based system, iChair. We would like to thank its developers. Following the review phases, 22 papers including 13 papers for Track I, 6 papers for Track II, and 3 papers for Track III were

accepted for publication in this volume of *Advances in Information and Computer Security*.

Advanced Environments, Tools, and Applications for Cluster Computing Oct 29 2022 Started by small group of well known scientists with the aim of sharing knowledge, experiences, and results on all aspects of cluster computing, the initiative of a workshop on cluster computing received more attention after IFIP WG 10.3 and IEEE Romania Section accepted our request for sponsorship. All papers were peer reviewed by two or three reviewers.

Picture Archiving and Communication Systems (PACS) in Medicine Mar 30 2020 This volume contains the proceedings of the NATO Advanced Study Institute on "Picture Archiving and Communication Systems (PACS) in Medicine" held in Evian, France, October 14- 26, 1990. The program committee of the institute consisted of H.K. Huang (Director), Osman Ratib, Albert Bakker, and Gerd Witte. This institute brought together approximately 90 participants from 15 countries. These proceedings are the accumulation of eight years of research and development results in PACS by various dedicated groups throughout the world. The purpose of this institute was to review the most recent technology available for PACS and some clinical results. The readers should notice the remarkable advances in this field by comparing the contents in these proceedings with those in a previous institute on "Pictorial Information Systems in Medicine" held August 27 - September 7, 1984 in Braunlage/Harz, Federal Republic of Germany, and published as Vol. 19 in this series. The institute was organized according to four categories: PACS components and system integration, PACS and related research in various countries and manufacturing companies, clinical experience and research support, and participants' scientific communications. In PACS components, we included image acquisition, workstations, data storage and networking. In system integration, topics on interfaces between Hospital Information System (HIS), Radiology Information System (RIS) and PACS, clinical reports, the ACR/NEMA standard, databases, reliability, and system integration were discussed. This lecture series emphasized the technical detail and "how to" aspects.

Cognitive Radio Oriented Wireless Networks Apr 23 2022 This book constitutes the thoroughly refereed post-conference proceedings of the 10th International Conference on Cognitive Radio Oriented Wireless Networks, CROWNCOM 2015, held in Doha, Qatar, in April 2015.
